REQUIREMENT CLARIFICATIONS

KIPP NYC Schools is clarifying requirements for the following services, all of which include E-Rate eligible services as specified on Form 470 #190000682.

1. Clarification 1: Service Requirements

- a. **SERVICE 1:** DIRECT INTERNET ACCESS – DIA
- b. **SERVICE 2:** CAMPUS WAN SERVICES – preference for MANAGED MPLS – **ALL LOCATIONS REQUIRED**

2. Clarification 2: Pricing & Award Structure

- a. Each service must be individually considered and priced – no contingencies that both services (DIA and MPLS) are required, or that a certain number of sites are required.
- b. As stated in the original RFP, “Vendors may bid on all or part of the services or all or some addresses. Bid awards may be by site or address or may be for all sites, or some combination thereof.”

3. Clarification 3: SST Office Address

- a. The future address of the ‘KIPP NYC Shared Services Team Office’ (noted as ‘moving’ in the original RFP) is as follows: **1501 Broadway, Floor 10; New York, NY 10036**
- b. This address applies to both DIA and MPLS for that site.

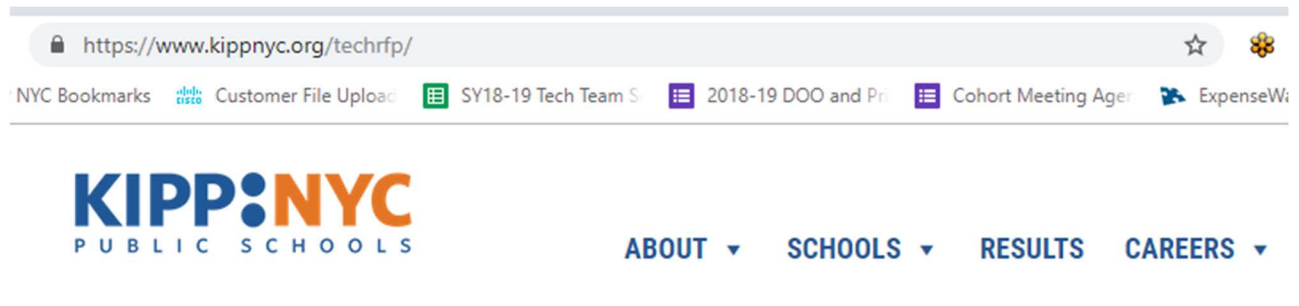
